
Properties can be let if they have an energy rating from A to E.

Primary energy use

The primary energy use for this property per year is 212 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

5. Replace single glazed windows with low-E double glazed windows	£3,300 - £6,500	£102
6. Solar photovoltaic panels	£3,500 - £5,500	£466
